Attention of the Trade and industry is invited to Trade facility No. 04/2007 circulated Vide VGN(30)Reconst\_RAC/07-08 dated 21.03.08.

2. It is necessary to reconstitute a RAC for the period dated 01.01.2009 to 31.12.2010. The Commissioner of Central Excise Pune III Commissionerate will be the Ex. Officio Chairman and the Additional Commissioner (Tech) of Central Excise Pune III Commissionerate will be the ex-officio secretary of the Committee.

3. The following shall be the composition of the committee.

4. In addition to the members specified above, the Commissioner of Central Excise, Pune III may Co-Opt not more than 3 members (organised Sector) & 2 members (SSI Sectors) for a specified period or for any particular meeting.

5. Function of the Committee :- The function of the RAC will be purely advisory as the Committee is intended for resolving the procedural difficulties of general nature. The Committee, may however discuss any matter including the policy behind individual cases but excluding the individual cases themselves and judicial and semi judicial matters.

6. Life period of the Committee :- The committee will function for a period of 2 years and accordingly the term of office of each nominated member will be for two years i.e. from 1.1.2009 to 31.12.2010. However, should on occasion arise to nominate a member in between the life period of the committee, his tenure of office will be for the remaining life period of the committee. On expiry of the term of the committee, a fresh committee shall be constituted.

7. Meeting of the Committee :- The committee will normally meet once in three months. The meeting will be held at Commissionerate Hdqrs or some Trade Centre in the Commissionerate.
8. Travelling and Daily Allowances :- The travelling and daily allowance from the place of residence of the members to the place of meeting will be admissible for attending the meeting of the Committee.
9. The Federation / Association, Chamber of Commerce and Industries and all the Trade and Industry in the Commissionerate are requested to suggest the names of suitable persons along with their qualification and expertise as specified in para 3 above for nomination in the committee for the Commissionerate.
10. Any member nominated on the RAC who remain absent for three consecutive meeting without adequate reasons will be deemed to have withdrawn / resigned from the committee and his place will be filled up by a fresh nomination. As such all the Trade Association and Chambers of Commerce and Industries etc are requested to suggest the names of only those person who will attend all or most of the meeting of the committee and take keen interest in the forum.
11. The name of members and suggestions if any may please be sent to the undersigned so as to reach not later than **25.01.09** The concerned Association / Chambers / Federation and Trade will be informed about the nomination of members and constitution of the Committee in due course.
