2. Those who desire to get the copies of the various Trade Notices / Trade facilities dealing with Central Excise matters only, for the **Calendar Year 2009** issued by this Commissionerate should deposit an amount of Rs.2200/- (Rupees Two thousand two hundred only) either in **Bank of Maharashtra, State Bank of India, or Bank of India on GAR-7 Challan under head 0038-0087 E.O.R.** adjustable by P.A.O. Central Excise Pune III and enclosed copy of the same along with written request to his effect latest by 26.01.2009. The request should be addressed to Assistant Commissioner (Tech), Central Excise, Hdqrs, Pune III Commissionerate Pune and should contain clear and complete address with Pin Code on which the Trade Notice is to be sent.

3. Those who desire to get the copies of Trade Notices / Trade Facilities on Service Tax only will have to deposit an amount of Rs. 2200/-(Rupees Two thousand Two Hundred only) either **Bank of Maharashtra, State Bank of India, Or Bank of India on GAR-7 Challan under head 0038-0087 E.O.R.** adjustable by P.A.O. Central Excise Pune III along with a written request to this effect by 26.01.2009. The request should be addressed to Assistant Commissioner (Service Tax), Central Excise Hdqrs, and Pune-III Commissionerate Pune. Those who desire to have Trade Notices on both Central Excise and Service Tax matters should send separate written request to the respective / Assistant Commissioner and the Subscription fee for the same shall be Rs 2200/-(Rs Two Thousand Two Hundred).

3. All the Trade Associations and Chamber of Commerce and Industries are requested to bring the contents of this Trade Notice to the Notice of their member constituents.
